

CHARGES TO PATIENTS

Your GP normally treats you under the NHS. However, like any other professional, your doctor will charge you a standard fee (as recommended by the BMA) for services that are excluded from the GP contract. In addition the practice is registered for VAT which means that some of these services will also attract this tax.
